

## **Bursary Application Guidelines and Conditions**

### **Purpose**

Murray Conservatorium is dedicated to promoting equity by incorporating fair practices in the design and delivery of its programs, in line with established policies. We are also committed to offering fee relief to the community and NSW Public Schools, where possible, through bursaries for those in need of financial assistance.

#### **Guidelines and Process**

- A Bursary Application Form must be submitted to the Conservatorium office. Applicants are required
  to include a 200-word summary outlining their (or their child's) commitment to music education and
  how the bursary will assist in continuing their education at Murray Conservatorium.
- Only one application per family, with provision for up to two students per form (additional forms can be used if necessary).
- Adult students are welcome to apply.
- Applicants may be required to attend an interview.
- Each application and the level of fee relief will be evaluated individually. All information provided by applicants will be treated with strict confidentiality.
- Applications from prospective students are accepted year-round.
- Bursaries are limited to a maximum of 5 years for any individual or family.
- Bursaries will be granted for the remainder of the calendar year at the discretion of the Conservatorium.

#### **Conditions of the Bursary**

Recipients of bursaries must:

- Demonstrate strong commitment to their chosen instrument, voice, or ensemble, and show satisfactory progress.
- Inform the Conservatorium of any changes in their financial circumstances.
- Note that bursaries are disbursed at the start of each term.
- For students seeking assistance for the 2025 academic year, applications must be submitted by the end of November in the year prior to the bursary being applied.

This policy ensures that bursary assistance is provided fairly and transparently, supporting the musical education of those in need while maintaining the Conservatorium's high educational standards.
